4. Resolution to **approve the Minutes of meeting** held on 26th November 2020.
5. **Passive Speed Watch signs** – positioning has been suggested and request sent to Lincs CC but they will ultimately decide on the positioning.
6. **Highways** – update on footpaths outside Broughton College and Spring Cottage. Potholes along Mill Lane and at Meeting House Lane reported.

7. **Planning** – 20/1127 – Creation of vehicular access and erection of gates at The Bothy – pending consideration; 20/1457 – new dwelling at 9 West Street – refused; 20/1461 – change of materials at New Grange, Sleaford Road – approved; 20/1488/1499/1516 – change of use and adoption of telephone kiosk – approved; 20/1538 – tree works at 112 High Street – approved; 20/1548 – new air source heat pump at Village Hall – pending consideration; 20/1603 – new car port at 101A High Street, BB – pending consideration; 20/1713 – tree works at 10 Meeting House Lane – pending consideration.
8. **Phone kiosk** – planning approved and contract signed and returned to BT. Apparatus will be removed by BT and lighting retained. Discussion and resolution as to way forward with regard to refurbishment and installation of defibrillator, book swap and seed swap.
